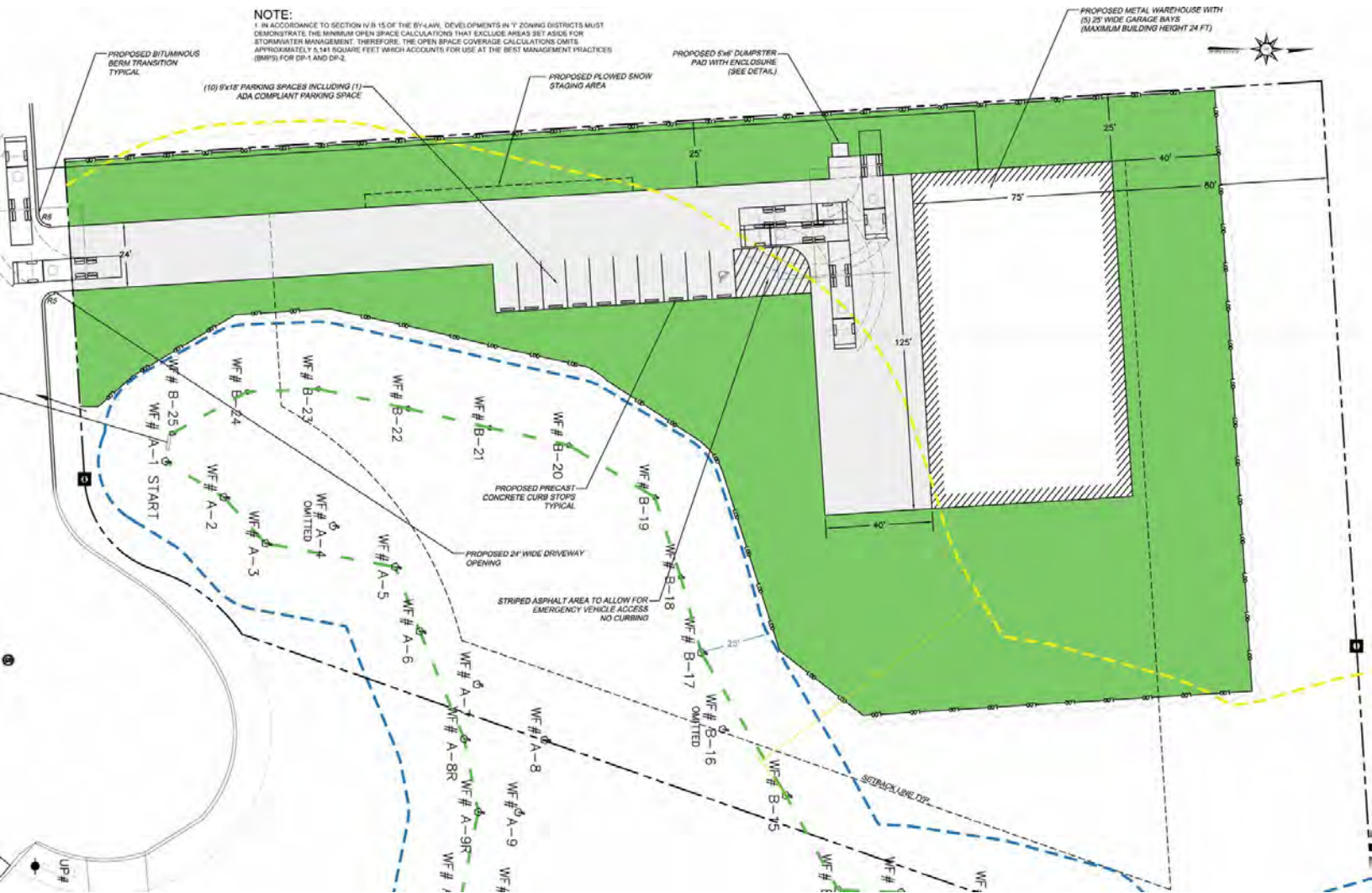

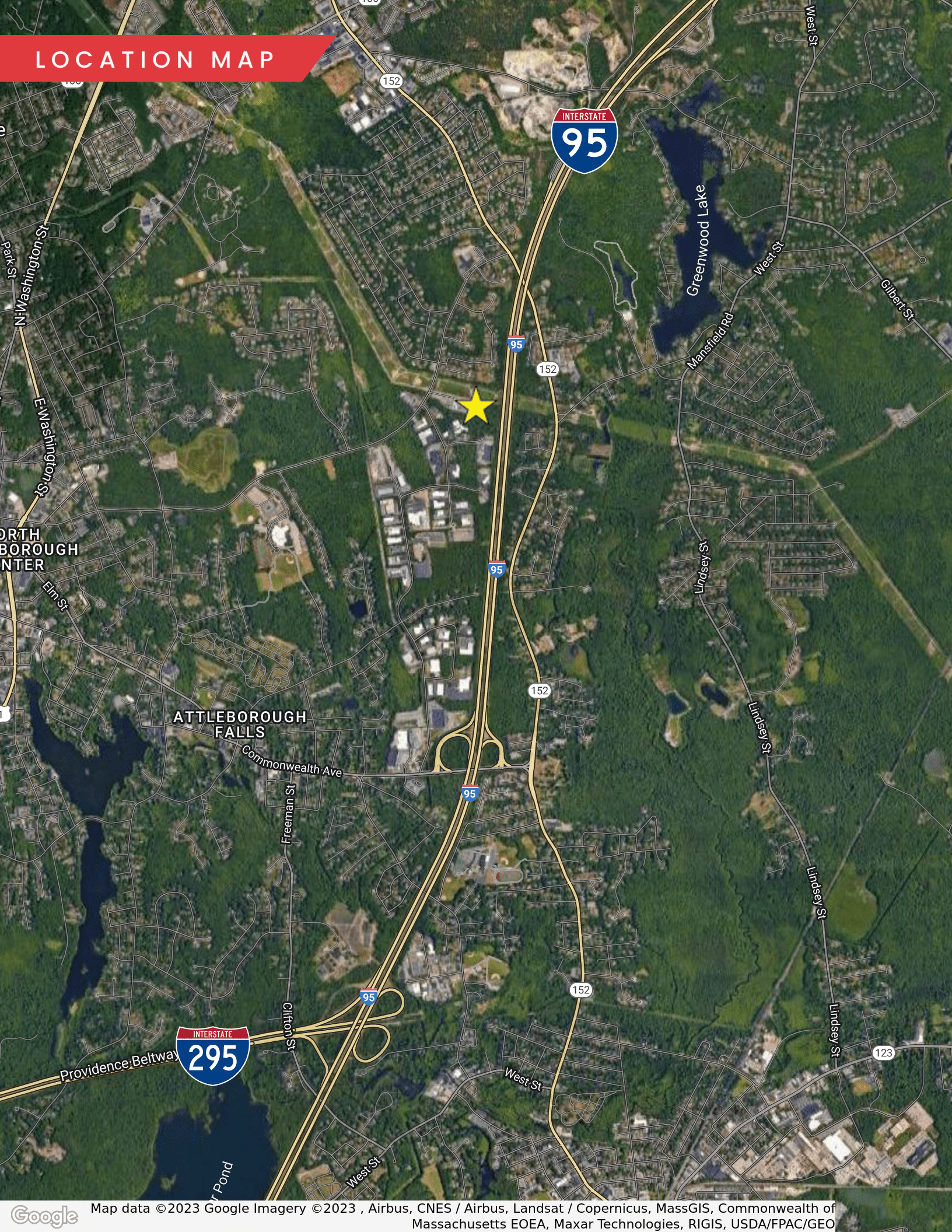
# SITE PLANS
